IDDE Outfall Investigation - The District is required to screen all outfalls. Due to the large number of outfalls in the District, a prioritization effort started in 2013 to identify high, medium and low priority outfall locations. The report includes charts and graphics that show the status of this effort. Mr. Long reviewed the results of this year's field investigations and inspections.

Question: Chairman Honerlaw asked if you find an illicit discharge the action necessary it says here "you use aggressive enforcement of applicable legal authorities" curious, how does the usual case go?

Answer: Mr. Long stated when a source is identified there is a notification process and, if the responsible party cooperates, it does not go past that point. The District has to act within its rules and regulations under the Ohio Revised Code. It cannot act in a punitive way, more of an advisory way. It could end up in the court system, but that is not turning out to be the case. Most of the operators the District has worked with were not aware that a problem existed. The District tries not to be heavy handed.

Question: Chairman Honerlaw asked, have we had any instances where we had to go to court?

Answer: Mr. Long stated that he didn't believe to date that there had been a single one.

- MCM 4 Construction Site Runoff Control The District performed approximately 3,200 site inspections - which averages 1.17 a month. The permit requires 1 per month. The District has seen an increase in construction commensurate with the recovery in the economy. These numbers show that the District is doing what it needs to do. The Soil and Water Conservation District Earthworks staff do really good work and make sure the program is being controlled properly.
- MCM 5 Post-Construction Storm Water Management These are methods to control storm water after site development. The District performed 67 plan reviews and 16 sites required a post construction best management practice. Not every site that gets developed requires these.
- MCM 6 Good Housekeeping and Pollution Prevention The District practices what it preaches and educates municipal and township staff. There were 290 government facility management staff educated this year and 69 facilities inspected. Hamilton County Public Health helps the District perform the training and inspections. A sign that the education is working has been evidenced by the fact that some of the complaints that are coming into the District are coming from same individuals that the District has been educating.

Answer: Mr. Long responded that the agreement stipulates this. Mr. Long stated that the District has had a number of communities return left over money because they completed the projects for less than the amount awarded.

Question from the floor: Can Mr. Long provide an update on the status of pursuing the balance of dollars owed by Cincinnati or others?

Answer: Mr. Long responded that Cincinnati paid what they felt was their fair share. There are discussions with the Prosecutor on how to pursue obtaining the difference between that and their billed fee. He mentioned that he is looking into one other community as well.
